#### INTRODUCTION

For more than 27 years, Washington Area Women's Foundation has stood in partnership with women and girls across our region, investing in their leadership, amplifying their voices, and resourcing the solutions they bring forward.



Since our founding, we've awarded **over \$17 million in grants** to **more than 215 local organizations** that share our commitment to gender, racial, and economic justice. At the heart of our work is a clear belief: those closest to the challenges are also closest to the solutions.

In a philanthropic landscape where **less than 2% of funding** goes to women and girls—and even less to women and girls of color—we're focused on closing that gap. We fund with trust, remove barriers, follow community guidance, and invest in transformation from the ground up.

In 2024, our programs demonstrated the full depth of that commitment. We:

- Laid the foundation for a new maternal health and birth equity program
- Protected early educator pay and expanded child care access
- Invested in youth-led projects and organizing efforts in Washington, D.C., and Prince George's County, Maryland
- Supported Black women nonprofit leaders to shift power and reimagine systems

#### **ABOUT**

#### WHAT WE DO

We operate at the intersection of community voice, grantmaking, and policy advocacy to advance gender, racial, and economic justice.

Our approach is rooted in trust. We invest in women, girls, and gender-expansive people of color not only because they have been historically excluded from funding, but because they are already working to transform their communities.

We fund community-led organizations, amplify their work, and follow their guidance. We know that solutions already exist in our communities. Our role is to direct resources to where they're needed most and eliminate barriers that impede progress.

#### **OUR MODEL**

We believe that women and girls of color are powerful agents of change. Despite often being unrecognized, their efforts have consistently advanced human rights and gender, racial, and economic justice in our communities for decades.



Our theory of change is that by increasing resources to, and recognizing the leadership of, women and girls of color, they will ignite needed change.

We put our theory into action through two key approaches:



**Grantmaking:** We provide general operating support to nonprofits and direct funding to individuals whose work aligns with our shared vision of justice. We prioritize organizations led by and serving women and girls of color, and we maintain an accessible, relationship-based process.



**Advocacy:** We collaborate with community partners to influence local and regional policy, and we advocate within philanthropy itself to shift the allocation of power and funding.

Our values—adaptability, honesty, diversity, and kindness

—shape everything we do. They influence how we build relationships, how we make decisions, and how we engage in coalitions.



#### MATERNAL HEALTH AND BIRTH EQUITY

In 2024, we established the groundwork for a new initiative aimed at improving maternal health outcomes for Black women and birthing individuals in our region.

We began by listening. Through a months-long landscape analysis focused on Washington, D.C., and Prince George's County, Maryland, we engaged nearly 20 community stakeholders —midwives, doulas, birth advocates, nonprofit leaders, and clinicians. Together, they painted a clear picture of what's broken and what's possible. Learn More.

While the findings were shocking, the solutions were evident. Community leaders advocated for increased investment in trusted birth workers, culturally rooted care models, and maternal mental health resources. They stressed the need for systems that uphold the dignity of birthing individuals and their families.

This work culminated in the development of our Maternal Health and Birth Equity Program, which officially launched in 2025. It reflects what we heard and is grounded in the lived experiences of those closest to the issue.

#### **Our Priorities:**

- Provide unrestricted grants to community-based maternal health organizations
- Elevate the leadership of Black and Brown birth workers
- Address maternal mental health and other social determinants of health
- Improve conditions for healthy pregnancies, safe births, and postpartum recovery

As we embark on this urgent work, our new program reallocates resources to where community members said they are most needed. Thank you to our partners: Boldly Go Philanthropy, A. James and Alice B. #### EARLY CARE AND EDUCATION

Early childhood education is a vital infrastructure, and the individuals who provide it are the backbone of our communities.

In 2024, the Early Care and Education Funders Collaborative (ECEFC), housed at The Women's Foundation, focused on transforming the systems that influence early learning. We prioritized funding for advocacy groups, grassroots organizers, and coalitions committed to ensuring that early educators—most of whom are women of color—receive the respect, compensation, and support they deserve.

Together, our grantee partners achieved significant policy wins, protected public funding, and advocated for changes that make the early education system more equitable for families, children, and providers alike. **Learn More**.

#### **2024 POLICY WINS**

#### Washington, D.C.

- Prevented salary cuts of up to \$11,000 for over
   3,600 early educators
- Preserved healthcare access for 4,000+ providers and families


#### Marvland

- HB1441 created new certification pathways for Pre-K teachers, expanding workforce access
- HB1139 extended funding for GOFCC, a no-cost program helping individuals especially in high-poverty areas become licensed child care providers

#### Virginia

- HB281/SB13 allowed zoning flexibility for office-based child care, expanding provider supply
- HB419/SB54 created a statewide funding model based on community need and demand, requiring annual reports on capacity and waitlists





### PROVIDER SPOTLIGHT

Lola Pavlovic, a devoted mother and administrator of an early childhood center in Fairfax, Virginia, exemplifies both the challenges and the potential of our child care system. Starting her career as an educator, she now oversees a center that serves 71 children and employs 20 staff members.

In 2024, she joined **over 100** parents and providers at the Virginia Promise
Partnership Advocacy Day, where she met with **75 lawmakers** to address the urgent needs facing the child care community, especially regarding staffing shortages and the instability of public funding.

Her advocacy secured a historic **\$1.1 billion** investment in early childhood care and education. Lola's story serves as a powerful reminder that when educators lead, systems change.

#### YOUNG WOMEN'S INITIATIVE

Young women and gender-expansive youth of color are leading movements, building community, and holding systems accountable. The **Young Women's Initiative (YWI)** exists to ensure they have the resources, support, and recognition they deserve.

In 2024, we reached **over 1,400** young people through YWI, supporting their leadership, amplifying their advocacy, and investing in their ideas.

For the first time, we expanded into **Prince George's County, Maryland**, partnering with **Community Youth Advance** to provide youth-led grantmaking and organizing opportunities to even more communities.

Through youth town halls, workshops, and other public convenings, young people shaped the conversation on safety, healing, opportunity, to name a few. **Learn More**.



Launched in 2019, **the Rock Star Fund** provides direct support to young women and gender-expansive youth of color who are developing bold, community-rooted solutions. Each year, youth leaders receive **\$2,000 microgrants**, selected by their peers through a participatory grantmaking process, to bring their visions to life.

Last year, we awarded grants to **14 Rock Stars** across Washington, D.C., and Prince George's County, Maryland. Their projects focused on mental health, healing spaces, storytelling, advocacy, creative expression, and more, each grounded in lived experience and a commitment to positively impact their communities.

experiences and centers
marginalized voices.

Favour wrote and curated original stories, poems, and essays that explored identity, girlhood, and what it means to navigate college as a young Black woman.

## BLACK WOMEN AND GENDER-EXPANSIVE LEADERSHIP PROJECT



Black women and gender-expansive leaders are driving change throughout our region, often while navigating systems that undervalue their leadership and deplete their resources.

Launched in response to our "Thrive As They Lead" report, the **Black Women's Leadership Project** continues to tackle the structural barriers identified by Black leaders themselves.


In 2024, we convened more than **60 nonprofit leaders** to deepen this work.

One theme emerged prominently: board governance. Participants stressed the importance of boards that share power, align with values, and create space for bold, authentic leadership. In response, we developed a board training program based on equity, healing, and accountability—shaped by Black leaders and informed by lived experience.
